## **The Hendricks Family Heart Hospital**

The new Hendricks Family Heart Hospital will be a unique heart specialty hospital. With a total cost of \$13.8 million, the Heart Hospital will be located on the fourth floor of Beloit Hospital with construction already underway. The new hybrid operating room will give high-risk patients additional options for treatments. Supplementary services, an eight-bed critical care unit, and two new cath labs will also be added. Our excellent cardiac care will continue during this expansion as the new Heart Hospital is finished at end-of-year 2017.

### **Hospice and Palliative Care**

Starting January 1, 2016, Beloit Health System and Beloit Regional Hospice became one. The partnership solidifies a long-standing relationship to promote a continuum of care to our patients. Hospice cares for over 100 patients a day and is a vital service to our community. Words cannot express the appreciation and admiration that patients and families feel towards the Hospice staff. In addition, in February, a new Palliative Care program was added. This is specialized medical care to support patients in all stages of a serious illness, not just at the end of life. Care can begin at diagnosis or at any time during the course of an illness and is offered alongside treatments seeking to cure the patient.

There are great changes happening at NorthPointe Health and Wellness in Roscoe. A \$15 million surgical center is under construction on the NorthPointe Campus and will provide needed services to patients at both NorthPointe and Beloit Memorial Hospital.





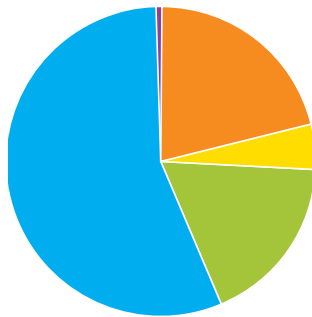
